The participants and their staff will be identified at the entrance of the wine fair by means of the entrance badges which are strictly personal and cannot be transferred to others. The organizers will provide the participants with a sufficient number of name badges.

The organizer has the right to ban the entry to anyone deemed undesirable.

The use of cameras, filming and video recording of the wine fair are forbidden unless the organizer has granted permission beforehand. Participants are allowed to take pictures and shoot videos only of their own stand.

The organizer will arrange for the photo shooting and filming of the wine fair at days and times which will be announced to both the participants and the visitors. Participants and their staff who do not wish to appear on photographs or/and the video which will be published or/and posted ought to notify the organizer in time and in writing.

The grounds of the wine fair and the storage area will be guarded 24 hours. The organizers are not liable for losses of the participants' belongings and shall not compensate the participants for theft or damage of their products.
